## 1. Disc Pump Firmware Licence

### 1.1 Definitions

“The Lee Company” - a Connecticut corporation, having its principal place of business at 2 Pettipaug Road, Westbrook, Connecticut 06498, UNITED STATES, together with its subsidiaries and affiliates.

“Disc Pump Product” - A piezoelectric micropump manufactured by The Lee Company, together with all associated products manufactured by The Lee Company, including but not limited to printed circuit boards and pump modules.

“Firmware” - The firmware provided by The Lee Company for use with Disc Pump Products, including any derivatives such as modified versions and versions in compiled form.

“The User” - The party to whom The Lee Company provides Firmware.

“Source Code” - A representation of the Firmware in human-readable text form.

“Compiled Code” - A representation of the Firmware in compiled form (e.g. binary file).

“End Product” - A system developed for or by The User that contains one or more Disc Pump Products.

### 1.2 Use

The User is granted the right to use, modify and adapt the Source Code solely for the purpose of developing systems to operate a Disc Pump Product and any related peripheral devices (e.g. valves, sensors, etc.) in conjunction with a Disc Pump Product. Use of the Source Code for any other purpose, including the development of systems or peripherals that do not operate a Disc Pump Product, is prohibited.

The User is granted the right to redistribute Compiled Code when supplying or supporting an End Product where the Compiled Code is directed towards operating a Disc Pump Product and any related peripheral devices (e.g. valves, sensors, etc.) in conjunction with a Disc Pump Product. Any other redistribution of the Compiled Code is prohibited.

Redistribution of the Source Code, except as expressly permitted by this section 1.2, is prohibited.

Any modifications to the Firmware that are shared by The User with The Lee Company for any reason are done so under the "MIT No Attribution License", included for reference in section 1.5. For the avoidance of doubt, this does not apply to any other software falling outside the definition of Firmware.
